The Art Deco Weekend Festival was started in 1978 by the Miami Design Preservation League to attract visitors to Miami Beach's Art Deco District and to raise awareness and appreciation of the arts and culture of the Art Deco era (approximately 1925–1945). In 2008, the festival attracted more than a quarter million visitors. Next year's event will take place Friday through Sunday, January 16–18, 2009, with the theme ***Down Argentine Way: Deco • Vino • Tango.***

### **VENDOR REQUIREMENTS**

All Food Vendors will be required to provide liability insurance, a fee for site clean-up, and a temporary license from the Florida Department of Business & Professional Regulation (DBPR) Division of Hotels and Restaurants. Rates for clean-up and temporary licenses will be sent to food vendors at a later date.

All rates are subject to change and do not include electrical services or tables and chairs. Your completed ***Electricity Order Form*** and ***Menu and Price List*** must be attached to this application in order for your application to be accepted.

### **NEXT STEPS**

Upon acceptance of your application, you will receive a Vendor Contract and a copy of the Rules and Regulations. If you wish to confirm the receipt of your application, please send application via the United States Postal Service, using the "Certified Receipt Requested" service. Vendors not accepted into the festival will receive a letter of notification and a refund of the deposit.

### **OFFICIAL PROGRAM LISTING**

The deadline for having your name published in the Art Deco Weekend Official Program is 15 October 2008 (only vendors who have paid in full by this date will be listed.) Please write your company name in this application as you would like it to appear in the program, and keep your food description brief so it will fit in the Food Vendor listing.

**TERMS**

1. Vendors will be expected to remain open during the hours that the festival is open. Hours will be posted.
2. I understand that MDPL can not guarantee exclusivity of my product.
3. I understand that MDPL reserves the right to assign or reassign any or all booth/trailer locations and spaces. No guarantee of a specific booth or space location is given or implied by MDPL
4. I understand that MDPL's refund schedule is as follows:
  - Cancellation prior to 01 September 2008 is subject to a cancellation fee of 25% of the full booth fee.
  - Cancellation between 01 September 2008 and 31 October 2008 is subject to a cancellation fee of 50% of the full booth fee.
  - No refunds will be made after 31 October 2008.
5. I understand that this application is not a contract. Space will only be granted to me by contract after the Art Deco Weekend Committee jury has accepted my application according to the jury system.
6. I will not be allowed to exhibit or sell at the Art Deco Weekend unless I have signed the contract, paid all fees in full and provided an insurance binder naming MDPL and CITY OF MIAMI BEACH as additional insured.
7. I understand I can not sell any liquids or beverages.
8. I understand that a refundable clean-up fee of \$300.00 will only be returned to me on the last day of the festival if, upon inspection of the space, the area has been cleaned and cleared. If vendor leaves without inspection the fee will not be refunded.
9. I understand that a surcharge may be levied for any late payments. I understand that I will be charged a fee for a bounced check.
10. I understand that I may sell only what has been approved on the attached **Menu and Price List**.
11. I have read, understand, and will comply with the attached electricity notice.
12. I accept all the terms set forth in this application and certify all the information supplied to be correct to the best of my knowledge.
